1. Payment conditions

2. Alteration to tour price

3. Cancellations

Cancellations received in writing before 30 days from the start of the tour will result in a cancellation fee of 50% per person. Cancellations received in 30 days or less before the tour start will result in a loss of all monies paid. There are no refunds for services not utilised on the tour. Travel insurance is highly recommended to cover tour members for the consequences of unforeseen events during the tour and for cancellation fees which could result from events such as illness, accident, death etc.

4. Minimum tour numbers
